** When charging outside the Czech Republic, the equivalent amount in the local currency is billed. For the conversion into the local currency, the exchange rate of the European Central Bank valid on the day preceding the executed transaction is used; the above-mentioned price (in CZK) is therefore converted into EUR and subsequently (from EUR) into the local currency.

III. General Provisions

- Calculation and billing shall be carried out in accordance with the Terms and Conditions of the Charging Service.
- The prices listed above include VAT.
- The unit price for charging an Electric Vehicle varies depending on the Tariff selected by the Customer. The Customer is entitled to choose the "Basic", "Standard", or "Premium" Tariff. If the Customer does not select the "Standard" or "Premium" Tariff, the Customer's Tariff shall be deemed to be the "Basic" Tariff (e.g., upon Customer registration).
- The Customer shall pay the flat-rate fee corresponding to the selected Tariff on a monthly basis, always on the Relevant Date. The Relevant Date is the day of the month on which the Customer registered or changed the Tariff. For example, if the Customer registered on 14 November 2023, the Relevant Date is the 14th day of each calendar month. If this Customer changed the Tariff on 5 December 2023, the Relevant Date shall, from the moment of the change, be the 5th day of each calendar month. If the Relevant Date does not occur in a given calendar month (e.g., the 29th day of February), the Relevant Date shall be the last day of that calendar month.
- The Customer is obliged to pay the above-mentioned flat-rate fee regardless of whether the Electric Vehicle was charged during the given month. If the Customer changes the Tariff during the month, the Relevant Date shall change accordingly, and the Customer shall, upon each such change, be required to pay the full flat-rate fee applicable to the newly selected Tariff.
- The flat-rate fee is charged for each commenced month, and the Provider shall invoice it to the Customer immediately after the selection (or change) of the relevant Tariff and, in subsequent calendar months, always on the Relevant Date.
- The payment card used to pay the price is verified by a pre-authorization hold of CZK 500 before each individual charging session or again at the moment the held amount is exhausted. The unused portion of the held amount is released immediately after the billing of the Charging Service price, but no later than 3 days after the card authorization.
- For the purposes of this Price List, the following terms shall have the meanings set out below:
 - ⚡⚡ (≤49 kW): charging from a Connector with an Output Power of the connector less than or equal to 49 kW,
 - ⚡⚡⚡ (≤149 kW): charging from a Connector with an Output Power of the connector of 50 kW or more and less than or equal to 149 kW,
 - ⚡⚡⚡⚡ (≥150 kW): charging from a Connector with an Output Power of the connector of 150 kW or more.
